Health Contract / Guarantee

We, at Bella Notte Puppies, offer healthy beautiful lines of AKC English Cream Golden Retrievers, CKC Goldendoodles, CKC Poodles! All sires and dams are AKC/CKC registered. Goldendoodles are a designer breed and each of our puppies are CKC registered. We offer this agreement for your protection, and believe it to be the best you can find anywhere. Before you bring your new "baby" home, it is necessary for you to read and fully understand the following agreement between you, the "Purchaser," and Bella Notte Puppies. The pet you are purchasing is NOT RETURNABLE except for the provisions stated in this agreement.

Initials: ____ / ____ 2. Our puppies are guaranteed to be in excellent health, to the best of our knowledge at the time of purchase. At 7-8 weeks of age, they are inoculated with their first shot and have been D-wormed 3 times. To validate this warranty, the Purchaser agrees to call an "authorized veterinarian" to secure an appointment for an initial examination. This examination must occur within three (3) calendar days from the pick up date. Any additional services including vaccinations, wormings, treatment of external parasites, etc. will be the purchaser's expense. If during this exam, the veterinarian finds the puppy to be unfit for purchase (does not include minor treatable illness) the puppy must be returned to Bella Notte Puppies within a five (5) day period from the examination. The Purchaser must procure and furnish written documentation from a veterinarian stating the diagnosis and/or cause of death, including vaccination history and x-rays, when needed. GENETIC problems are guaranteed up until 2 years of age. If the breeder can be of any help, please feel free to call or text any time. Claims must be made within the warranty period and are subject to verification by the breeder. Bella Notte Puppies will, at your option, replace the puppy with a puppy of equal purchase price.

Initials: _____ / _____ 3. Over the years of breeding and raising dogs, we have encountered a few circumstances that can be harmful to your puppy and have excluded these treatments from our guarantee:

3 a. The Lepto shot is not approved until your puppy is at least 1 year old.

3 b. Never give your puppy the heartworm six (6) month shot program. If your puppy receives this treatment, all guarantees that are written, verbal or otherwise implied shall be voided. Heartworm tablets are approved only at the right age. (This is around 8 weeks old depending on the weight and size of the puppy.)

3 c. Hernias are caused by the dam pulling the umbilical cord to hard. If any of our dogs produce hernias in more than one litter we retire them

3 d. Sometimes a foreign object or when another animal scratches the puppy's eye, can be a reason for a puppy to develop Cherry Eye. This can be fixed by your Veterinarian, sometimes without surgery. However, because of this, we strongly suggest not letting your puppy stick their head out of the window in a moving vehicle.

3 e. Coccidia can be caused by your puppy having stress or ingesting infected soil, water, or other substances containing feces. Coccidia will cause your puppy to produce diarrhea and can be fatal. Your veterinarian can perform a fecal test to diagnose coccidiosis. If your dog is infected, your vet can provide effective medications.

3 f. We treat our puppies with Albon three (3) days before they leave for their new homes. If you are picking up your puppy from the airport please be prepared. Bring paper towels, wipes, and a clean towel. Do not let your puppy go to the bathroom anywhere other dogs may have been. Let them go on a towel or newspaper. Parvo is everywhere, and your puppy is not protected until it has had its last vaccination.

3 g. If for whatever reason should you need to take your puppy to an Emergency 24-hour Clinic, all guarantees that are written, verbal or otherwise implied shall be voided.

Initials: _____ / _____ 4. Remember stress brings on illness! This puppy is like a little baby, just building his or her immune systems! Pamper and monitor your puppy each and every day! Watch for any signs of illness such as: NOT eating, listlessness, coughing, diarrhea, vomiting or nasal discharge. If any of these signs should arise, the Purchaser agrees that the puppy will receive professional medical attention. If you have any questions please call or text 678-777-4856 or 916-613-3270.

Initials: _____ / _____ 5. Conditions resulting from injury, negligence or cruelty WILL NOT BE COVERED. This includes, but is not limited to: being left on a chain or unattended in a vehicle, beaten, teased, trained for attacking, guarding property, or being used for dog fighting. This warranty/agreement is non-transferable and valid only for the original Purchaser(s).

Initials:_____/_____ 6. Please prevent your pet from "free roaming" outdoors where dogs with unknown health statuses (until they have had their 3 required vaccines) may have visited. By keeping your pet confined within a fenced yard or household, you greatly reduce the possibility of introducing your puppy to deadly diseases. We have given the proper vaccines to date, for any claim you must show, from your veterinarian, documentation that the puppy has been properly vaccinated and received annual boosters throughout its life.

Initials:_____/_____ 6 a. Never put your puppy on the floor, ground, furniture, or an examination table unless you have personally observed that it has been sanitized and disinfected. Although necessary, the veterinarian's office is one of the most dangerous places you can take your puppy.

Initials:_____/_____ 7. Should you not want your puppy anymore, please send them back to us. We will not allow any of our puppies to be placed in a shelter, abandoned, or to simply be without a loving home for any reason. We will take your puppy back and find a good home for them. You will not receive a refund upon return due to no longer wanting your fur-member.

This written agreement is the entire agreement concerning the health, development, use or loss of this pet. I will not rely on any oral statements contrary to this agreement unless they are in writing. I understand there are no provisions for returning this pet other than stated in this agreement. I have read and completely understand this agreement including the conditions, all of which I accept.
